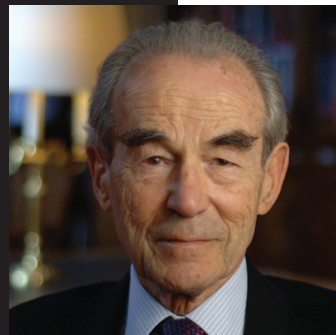
The Honourable Justice Rosalie Silberman Abella



Justice Rosalie Abella was appointed to the Supreme Court of Canada in 2004, the first Jewish woman so honored. She had been on the Ontario Court of Appeals since 1992. She was the sole commissioner of the 1984 federal Royal Commission on Equality in Employment, creating the term and concept of “employment equity”. The theories of “equality” and “discrimination” she developed in her report were adopted by the Supreme Court of Canada in its first decision dealing with equality rights under the Canadian Charter of Rights and Freedoms in 1989.

Justice Abella was appointed to the bench in 1976, at 29 years of age. She was made a Senior Fellow of Massey College in 1989, a Fellow of the Royal Society of Canada in 1997, and a Fellow of the American Academy of Arts and Sciences in 2007. She is a graduate of the Royal Conservatory of Music in classical piano. Justice Abella was born in a Displaced Person’s Camp in Stuttgart, Germany on July 1, 1946. Her family came to Canada as refugees in 1950.

The Honorable Robert Badinter



Robert Badinter is a French jurist, professor, and author. He is a leading activist against the death penalty.

His distinguished career includes a role as France's Minister of Justice from 1981 to 1986, during which time he sponsored the abolition of the death penalty (1981) and promoted other civil-rights reforms. He has been President of the French Constitutional Council, a member of the French Senate, President of the Arbitration Commission of the Peace Conference on Yugoslavia, member of the Brussels Convention for the European Constitution and of the high-level panel appointed by UN Secretary General Kofi Annan to advise the organization on reforms necessary to cope with emerging challenges. He is currently a member of the International Commission against the Death Penalty.

M. Badinter is also the author of a number of books, as well as an opera libretto.

Professor John Q. Barrett



John Q. Barrett is a Professor of Law at St. John's University in New York City. He also is the Elizabeth S. Lenna Fellow and a Board member at the Robert H. Jackson Center in Jamestown, New York.

Professor Barrett is writing the biography of Justice Robert H. Jackson (1892-1954), U.S. Supreme Court Justice and chief prosecutor at Nuremberg of the principal Nazi war criminals. Justice Jackson is recognized worldwide as one of the finest writers, lawyers, judges, leaders and lives of the 20th century. Barrett discovered and introduced Jackson's now acclaimed memoir *THAT MAN: AN INSIDER'S PORTRAIT OF FRANKLIN D. ROOSEVELT*, which is both F.D.R. biography and Jackson autobiography. Barrett's "Jackson List" emails—<http://thejacksonlist.com/>—reach well over 100,000 readers around the world.

Professor Barrett is a renowned teacher, writer, public commentator and lecturer. He is a graduate of Georgetown University and Harvard Law School and served as a law clerk to U.S. Circuit Judge A. Leon Higginbotham, Jr.; as Associate Counsel in the Office of Independent Counsel Lawrence E. Walsh (Iran/Contra); and as a U.S. Department of Justice attorney.

The Honorable Justice Dorit Beinisch



In 2006, 11 years after she was appointed Justice of the Israeli Supreme Court, **Dorit Beinisch** became the first woman to be named President of the Supreme Court.

In 1989, after a distinguished career as a lawyer in public, Ms. Beinisch was appointed State

Attorney of Israel, the first woman to hold that position. In this capacity she was in charge of all state attorneys in the country, and represented the state in a variety of litigation (civil, criminal and constitutional), mainly before the Supreme Court.

As a Supreme Court justice, she ruled in numerous cases relating to human rights, minority rights, terrorism and national security. Among her numerous court opinions: a decision holding that parents cannot use corporal punishment against their children; a ruling against privatization of prisons, holding that a privately managed and operated prison violates constitutional rights to personal freedom and human dignity; and a decision finding that a portion of Israel's Unlawful Combatants Law authorizing administrative detentions violated a detainee's rights to liberty. And she ruled that the "Tal law" – which exempted ultra-Orthodox Jews from military service – was unconstitutional. Dorit Beinisch always stressed protection for the rights of women, children, and the powerless.

Professor Michael Berenbaum



Michael Berenbaum is a writer, lecturer and educator consulting in the conceptual development of museums and historical films. He is director of the Zigi Ziering Institute: Exploring the Ethical and Religious Implications of the Holocaust at the American Jewish University, where he is a professor of Jewish

Studies. He was executive editor of the Second Edition of "The Encyclopaedia Judaica" that transformed the classic 1972 work; it oof 22 volumes and 25,000 articles.

Mr. Berenbaum's most prominent work in the museum world was directing the creation of the United States Holocaust Memorial Museum. He was conceptual developer on the Illinois Holocaust Museum and Educational Center and the Memoria y Tolerancia in Mexico City. He is currently at work on the Memorial Museum to Macedonia Jewry in Skopje and an Ultra-Orthodox Museum in Brooklyn as well as Holocaust and Tolerance Centers in Dallas, Texas.

He has written and edited 20 books, scores of scholarly articles, and hundreds of journalistic pieces. His film work includes co-producing "One Survivor Remembers: The Gerda Weissman Klein Story," which won an Academy Award and an Emmy Award, and acting as consultant on a number of award-winning documentaries on Holocaust-related themes.

Elisabeth Buettner



Elisabeth Buettner holds a M.A. in European Studies from the Faculty of International and Political Studies at the Jagiellonian University in Krakow, Poland. Since 2011, she has been a PhD candidate at the Institute of European Studies, Holocaust track. Her dissertation topic is “The Fate of German Prisoners of the Concentration Camp Auschwitz”.

She has been a trainee at the Polish-German Youth Organization in Warsaw (2009) and the International Youth Meeting Center in Oświęcim (2011), where she developed two historical workshops for youth groups. She participated in the project “Study of Attitudes toward Jews, the Holocaust and the Memory of the Holocaust among Polish Youth” at the Center for Holocaust Studies of Jagiellonian University. Since 2012, she translates survivor meetings at the Galicia Jewish Museum in Krakow. Her research interests include: anti-Semitism, the history of the concentration camp Auschwitz-Birkenau, as well as Polish-Jewish relations. Currently, she is working as a translator.

Professor Irwin Cotler



Irwin Cotler is the Founder and Chair of the Raoul Wallenberg Centre for Human Rights, Emeritus Professor of Law at McGill University, former Minister of Justice and Attorney General of Canada and longtime Member of Parliament, and international human-rights lawyer. As Minister of Justice and Attorney-General, he initiated the first-ever comprehensive reform of Canada’s Supreme Court appointment process and helped make it the most gender-representative Supreme Court in the world; initiated the first-ever law on human trafficking; and crafted the first ever marriage equality legislation.

He headed the Canadian delegation to the Stockholm Conference on the Prevention and Combating of Genocide, affirming also the Responsibility to Protect Doctrine as a centerpiece of Canadian policy, while initiating the first ever prosecutions for incitement to genocide and for the commission of mass atrocity crimes and genocide in Rwanda. He has served as counsel to prisoners of conscience including Andrei Sakharov and Natan Sharansky (Soviet Union), Nelson Mandela (South Africa), Dr. Saad Eddin Ibrahim (Egypt) and, more recently, imprisoned Saudi Arabian blogger Raif Badawi, and imprisoned Baha’i leadership in Iran.

Among his honors, he was the first Canadian recipient of the International Raoul Wallenberg Foundation’s Centennial Medal; the first recipient of the Roméo Dallaire Award for Human Rights Leadership, was elected 2014 Canadian Parliamentarian of the Year by his colleagues, and received the Law Society of Upper Canada’s Inaugural Human Rights Award. He is an Officer of the Order of Canada, Canada’s highest civilian award, and is the recipient of eleven honorary doctorates.

Professor Alan Dershowitz



Professor Alan M. Dershowitz is a Brooklyn native who has been called the United States' "most peripatetic civil liberties lawyer" and one of its "most distinguished defenders of individual rights." He is Felix Frankfurter Professor of Law (emeritus) at Harvard Law School. He joined its faculty at the age of 25, and at 28 became the youngest full professor in the school's long history.

He has published more than 1000 articles in magazines, newspapers, journals and blogs and is the author of 32 fiction and non-fiction works with a worldwide audience, including #1 bestseller "Chutzpah" and five other national bestsellers. His latest book is Abraham: The World's First (But Certainly Not Last) Jewish Lawyer." His autobiography, "Taking the Stand: My Life in the Law," was published in 2013.

In addition to his numerous law review articles and books about criminal and constitutional law, he has written, taught, and lectured about history, philosophy, psychology, literature, mathematics, theology, music, sports – even delicatessens.

In 1983, the Anti-Defamation League of the B'nai B'rith presented him with the William O. Douglas First Amendment Award for his "compassionate eloquent leadership and persistent advocacy in the struggle for civil and human rights." In presenting the award, Nobel Laureate Elie Wiesel said: "If there had been a few people like Alan Dershowitz during the 1930s and 1940s, the history of European Jewry might have been different."

He has been the subject of two New Yorker cartoons, a New York Times crossword puzzle, and a Trivial Pursuit question. A sandwich at Fenway Park has been named after him—pastrami, of course.

Natalia Dolinska



Natalia Dolinska started her violin education at age of seven. Now, after 20 years, she has graduated Academy of Music and she is still searching for more to learn. Her current musical interests include not only classical but also jazz, film and early baroque and renaissance music. She continues to study baroque violin with world famous violinist Sirkka-Liisa Kaakinen Pilch.

Natalia has participated in master classes led by famous professors like Kaja Danczowska, Wiesław Kwaśny, Grigori Zhislin, Levon Ambartsumian. Natalia is also a member of Early Music Ensemble Salsamentum and founder of Krakow's Chamber Orchestra.

The Honourable Lord John Dyson



The Rt. Hon. Lord Dyson was appointed as Master of the Rolls as of Oct. 1, 2012. The Master of the Rolls is the head of Civil Justice, and the second most senior judicial position in England and Wales, after the Lord Chief Justice.

He was called to the bar (Middle Temple) in 1968.

He was made a bencher for Middle Temple in 1990. He was appointed as a Queen's Counsel in 1980, and his first judicial appointment was as a Recorder held between 1986 and 1993. He was appointed as a Judge of the High Court of Justice for 1993-2001. He was also the Presiding Judge for the Technology and Construction Court between 1998 and 2001. In 2001 he was appointed as a Lord Justice of Appeal and elevated to the Supreme Court in 2010.

In his long judicial career, he has decided many leading public law and human rights cases involving the interpretation of the European Convention on Human Rights.

Ambassador Stuart Eizenstat



Stuart Eizenstat heads international trade at Covington & Burling LLP in Washington, DC. His work focuses on resolving international trade problems and business disputes with the US and foreign governments.

During a decade and a half of service in four U.S. administrations, Ambassador Eizenstat held a number of key senior positions, including chief

White House domestic policy adviser to President Jimmy Carter, where his recommendation to the President to create residential commission on the Holocaust, chaired by Eli Wiesel, led directly to the creation of the U.S. Holocaust Museum. He served as U.S. Ambassador to the European Union, Under Secretary of Commerce, Under Secretary of State, and Deputy Secretary of the Treasury in the Clinton Administration, he also served as Special Representative of President and Secretary of State on Holocaust-Era Issues, negotiating over eight billion dollars in negotiating major agreements with the Germans, Austrians, and other European countries for victims of Nazi persecutions, covering restitution of property, payment of slave enforced laborers and insurance policies, recovering of Nazi looted art, and bank accounts. He played a prominent role in key international initiatives, including the Transatlantic Agenda with the European Union, the development of the Transatlantic Business Dialogue among European and US CEOs, and the negotiation of the Kyoto Protocol on global warming, where he led the US delegation.

His book on these events is "Imperfect Justice: Looted Assets, Slave Labor, and the Unfinished Business of World War II." He has also written a book "The Future of the Jews: How Global Forces are Impacting the Jewish People, Israel, and Its Relationship with the United States." He is a frequent contributor to major publications and often speaks on international topics.

He has eight honorary Ph.D.'s and has received special awards from the U.S., Israeli, French, German, Austrian, and Belgium governments.

Dr. Aleksandra Gliszczynska-Grabias



Professor Gliszczynska-Grabias is Senior Researcher at the Poznań Human Rights Centre, Institute of Law Studies of the Polish Academy of Sciences. Her expertise includes anti-discrimination and constitutional law, freedom of speech, and hate crimes, and more generally, international protection of human rights.

Her doctoral thesis formed the basis of her 2014 book, *Combating Antisemitism: International Law Instruments*. She has published several scholarly articles and co-authored and edited other books, including the forthcoming *Law and Memory: Addressing Historical Injustice through Law*. (Cambridge University Press 2016)

Prof. Gliszczynska-Grabias has participated in many research projects, including *Europe at the Edge of Pluralism: Legal Aspects of Diversity in Europe*. She has prepared numerous expert reports for the Polish Parliament, EU and Council of Europe institutions, and think-tanks and NGOs. She has facilitated various fora on human-rights issues. She is a founding member of the Council for European Studies Research Network on Transnational Memory, and is a member of the Institute for the Study of Global Antisemitism and Policy, and the Academic Advisory Board of the Community of Democracies.

Brooke Goldstein



Brooke Goldstein is a New York City-based human rights attorney, author, and award-winning filmmaker. She is director of The Lawfare Project, a nonprofit organization dedicated to raising awareness about and facilitating a response to the abuse of Western legal systems and human-rights law. She is also the founder and

director of the Children's Rights Institute, a nonprofit organization whose mission is to track, spotlight, and legally combat violations of children's basic human rights around the world. CRI has a special focus on the state-sponsored indoctrination and recruitment of children to become suicide-homicide bombers, child soldiers, and human shields.

Ms. Goldstein is the author (with Aaron Eitan Meyer) of *"Lawfare: The War Against Free Speech: A First Amendment Guide For Reporting in an Age of Islamist Lawfare"*, offering guidance to journalists who wish to speak truthfully about the national-security threats faced by liberal democracies.

Her award-winning documentary *"The Making of a Martyr"*, uncovers the illegal, state-sponsored indoctrination and recruitment of Palestinian children for suicide-homicide attacks.

Phyllis Greenberg Heideman



Currently serving as President of the International March of the Living, **Phyllis Greenberg Heideman** has devoted much of her life to the preservation, protection and future of Holocaust education. She previously served as Chair of the March of the Living International Advisory Board, a position she assumed following the completion

of her five-year term as a George W. Bush Presidential Appointee to the United States Holocaust Memorial Council. Accepting many responsibilities and serving in many diverse roles throughout her life, she is the recipient of numerous awards and currently serves as Co-Chair of the Israel Forever Foundation, on the Republican Jewish Coalition Board of Directors and as Trustee of the B'nai B'rith World Center in Jerusalem. In her capacity as President and General Manager of the Louisville Thunder Professional Indoor Soccer Team, she served on the Board of the American Indoor Soccer Association and guided her team to a National Championship. Her entrepreneurial acumen and broad understanding of the business world serve all her endeavors well, including her position as Administrator of the DC law firm of Heideman Nudelman & Kalik, PC.

Richard D. Heideman



Mr. Heideman's Washington, DC, law firm of Heideman Nudelman & Kalik is lead counsel representing American victims of terrorism in claims against Libya, Syria, Iran, the PLO, and others accused of providing material support for terrorism. In recent years, the firm has been awarded several large landmark judgments.

Mr. Heideman is Chair of the Institute for Law and Policy at the Hebrew University Faculty of Law, Chair of The Israel Forever Foundation, and was recently Chair of the United States Holocaust Memorial Museum Lawyers Committee in Washington, DC.

He has been President of B'nai B'rith International and an NGO delegate to the UN World Conference on Women in Kenya. In 2001, he was Head of Delegation to the UN World Conference Against Racism in Durban, South Africa; in 2009, he was Head of Delegation to the UN Durban Review Conference; and in 2011 Chairman of the UN Durban 10-year assessment event.

A noted public speaker, he frequently appears on television as a legal analyst. He is the author of "The Hague Odyssey: Israel's Struggle for Security on the Front Lines of Terrorism and Her Battle for Justice at the United Nations" and is widely published elsewhere.

Malcolm Hoenlein



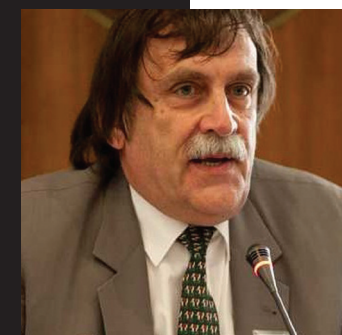
In 1986, **Malcolm Hoenlein** was elected CEO/ Executive Vice-Chairman of the Conference of Presidents of Major American Jewish Organizations, the central co-ordinating body on international and national concerns for 50 national Jewish organizations. Previously, he served as Founding Executive Director of the Jewish

Community Relations Council of Greater New York, which played the same role for Jewish organizations in metropolitan New York. Prior to that, he was the founding Executive Director of the Greater New York Conference on Soviet Jewry.

A National Defense Fellow in the University of Pennsylvania's Near East Center, Mr. Hoenlein taught International Relations and was a Middle East specialist at the Foreign Policy Research Institute. He has received numerous recognitions from foreign governments, including the highest civilian decoration from King Mohammad VI of Morocco. He was appointed by three Presidents as a U.S. delegate to the Organization for Security and Co-operation in Europe and participated in several Presidential delegations.

Mr. Hoenlein has travelled the globe meeting with world leaders and heads of Jewish communities. He has written and lectured across the U.S. and abroad and is frequently consulted on public- policy issues. He appears regularly in the media and co-hosts the nationally syndicated "John Batchelor Show" on the ABC radio network weekly.

Professor Zdzislaw Mach



Professor Mach is Professor in sociology and anthropology at the Jagiellonian University in Krakow, Poland. Founder of the Institute for European Studies at the Jagiellonian and one of the main authors of the European Studies curriculum in Poland, he is also Head of the Centre for European Studies and the UNESCO

Chair in Education about the Holocaust.

His broad international teaching and research experience includes Université Montpellier III Paul Valéry, University College Dublin, University of Chicago, Oxford University, University of Amsterdam, and the University of Edinburgh. His research interests cover identity issues such as nationalism, minorities, and ethnicity; the development of European citizenship, migration; and the reconstruction of identity; the ethnic origin of nations and construction of identities, as well as the development of the idea of Europe.

Dr. David Machlis



Since 1967, Professor Machlis, an economist, has been a faculty member at Adelphi University in Garden City, New York. His considerable contributions to furthering understanding of genocide and human rights stem from “my strong interest in designing, developing, and implementing educational programs that teach

about the dangers of prejudice and intolerance through the study of the Holocaust.”

To that end, he has organized exhibitions and conferences in venues ranging from the United Nations to Auschwitz. Among them, he created and implemented the Liberators component of the 2012 March of the Living, which featured testimony from American liberators of the death camps. He has also orchestrated the visits to Auschwitz of celebrities such as Oprah Winfrey and well-known survivors such as writer Elie Wiesel and Branko Lustig, producer of “Schindler’s List.”

Mr. Machlis has co-ordinated many other symposia and conferences focusing on the Holocaust and human rights, including missions to Poland and commemoration of V-E Day.

Edward Mosberg

HOLOCAUST SURVIVOR

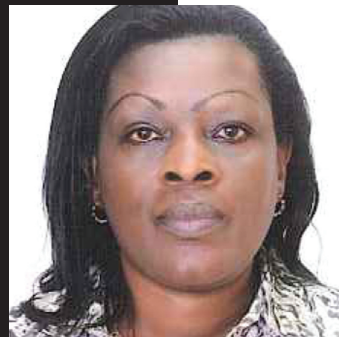


Edward Mosberg was born on January 6, 1926 in Kraków, Poland to Bronislawa and Ludwik Mosberg. Mosberg had two sisters, Helena and Karolina. Prior to the war, Mosberg attended a private school in Kraków. When Edward Mosberg was just 15, in 1941, he and his family were forced by the Nazis to move from their apartment to the ghetto in Kraków, Poland. His father, Ludwik, was murdered in 1941. In 1942, his grand-
parents, aunts, uncles and cousins – 16 family members in all - were murdered in Belzec. After the liquidation of the ghetto in March 1943, Mosberg, along with his mother and two sisters, were transferred to the concentration camp Plaszow, where he worked in the the offices of Commandant Amon Goth, of “Schindler’s List” infamy.

In May, 1944, Edward’s mother and his wife’s brother, just 9, were murdered in Auschwitz. Edward’s wife, Cecile, whom he met in a concentration camp, witnessed her mother’s murdered body dragged and set afire in Plaszow. In August, 1944, Mosberg was transferred from Plaszów to Mauthausen, where he worked in the stone mine carrying boulders up the infamous 186 Death Steps. That same year he was transferred to the concentration camp Linz. On May 5, 1945, the day of liberation, SS soldiers marched Edward and other prisoners from Mauthausen concentration camp to dynamite-filled caves. Fortunately, the dynamite failed to explode. Throughout the war, Mosberg’s wife, Cecile, was in several ghettos and concentration camps including Wieliczka, Mielec, Dubienka, Kraków Ghetto, Plaszów concentration camp, Auschwitz-Birkenau, Bergen Belsen, and Gelsenau. She was liberated from Mauthausen in May of 1945.

In 1947, Edward and Cecile were married. In 1951, the family, now with a daughter, emigrated to the United States, where two more daughters were born and where he established a real-estate business. Edward and Cecile also have six grandchildren and two great-grandchildren.

Justice Marie Thérèse Mukamulisa



Justice M-Thérèse Mukamulisa lost most of her family in the 1994 genocide of the Tutsi ethnic minority in Rwanda. After a long struggle to pursue her studies as a member of the Tutsi ethnic minority that faced discrimination, she was appointed as a Judge of the Supreme Court of Rwanda in 2003 which includes a significant part related to human rights and their protection, and the country commitment to respect the principle of involving at least 30% of women in all decisions-making organs.

She is member of the country's Judicial High Council, as well as a member of regional and international networks of judges such as the International Hague Network of Judges (IHNJ).

Before her appointment, she was one of 12 commissioners who drafted the Rwandan post-genocide Constitution.

She has also been a Visiting Lecturer in Comparative Law at the National University of Rwanda, and Legal Officer, Executive Secretary and Legal Counsel of CCOAIB (an umbrella group of NGOs in Rwanda).

Following her law degree (civil law) from the National University of Rwanda, she received an LLB in common law from the University of Moncton in New Brunswick. She holds also a Masters in Genocide Studies and Prevention from CCM-NUR (Rwanda).

His Magnificence Prof. Wojciech Nowak



His Magnificence Prof. Wojciech Nowak is in his second term as Rector of the Jagiellonian University in Krakow, Poland. He was Vice-Rector from 2008-2012, Prior to that, he was Dean of the university's Faculty of Medicine.

With an extensive and distinguished background in surgery, in which he has two degrees, His Magnificence Prof. Wojciech Nowak has been, since 2010, President of the European Society of Surgery, and a member of several surgical examination boards in Europe. His medical expertise is in the fields of endocrinology, transplantology, breast cancer, and surgical treatment of cancers of the digestive system.

A member of numerous Polish and European scientific associations, His Magnificence Prof. Wojciech Nowak is the author, co-author, or organizer of 133 publications, three monographs, and 285 conferences.

The Honorable Luis Moreno Ocampo



Luis Moreno-Ocampo is Global Practice Counsel at Getnick & Getnick LLP in New York City and is Associated to the Carr Center for Human Rights at Harvard University.

He was the first Chief Prosecutor of the permanent International Criminal Court, in

The Hague, from 2003-2012. His office was involved in 20 of the most serious crises of the 21st century, including Iraq, Korea, Afghanistan, and Palestine. He has conducted investigations in seven countries, including Libya and Sudan.

Previously, Mr. Moreno-Ocampo played a crucial role during the transition to democracy in Argentina. In 1985, he was deputy Prosecutor in the Junta trial and later led investigations against guerrilla leaders and army officers involved in two military rebellions, as well as many cases of corruption involving high-level public officers.

In 2011, The Atlantic magazine included him among the Brave Thinkers, people risking their reputations, fortunes, and lives in pursuit of big ideas. That same year, Foreign Policy designated him one of the 100 Top Global Thinkers in the world's marketplace of ideas.

Greg Peterson



Mr. Peterson is co-founder of the Robert H. Jackson Center (named for the Chief U.S. Prosecutor at the International Military Tribunals in Nuremberg) in Jamestown, NY and is a partner in the law firm of Phillips Lytle LLP.

He received his Juris Doctor in 1976 from

Dickinson School of Law in Carlisle, PA., and Bachelor of Arts in 1973 from Allegheny College in Meadville, PA. He is admitted to the US Supreme Court and is a member of the American Bar Association, New York State Bar Association, and the Pennsylvania Bar Association, as well as the local Bar Associations and sits on the boards of many organizations.

Mr. Peterson is also the recipient of the 2010 Toby Tickin Back Award for Excellence in Holocaust Education; the 2011 Distinguished Service Award, Youth and Citizenship Committee of the New York State Bar Association; and in 2012 was recognized by The Second Circuit Judicial Council Committee on History, Commemorative Events and Civic Education for his significant contribution toward preserving the legacy of Supreme Court Justice Robert H. Jackson.

Ambassador Samantha Power



Ambassador Samantha Power is the U.S. Permanent Representative to the United Nations and a member of President Obama's Cabinet. At the United Nations, Ambassador Power works to advance U.S. interests, promote and defend universal values, and address pressing global challenges to global peace, security, and prosperity.

Prior to serving as U.S. Permanent Representative to the United Nations, Ambassador Power served as Special Assistant to the President and Senior Director for Multilateral Affairs and Human Rights on the National Security Staff at the White House. In this role she focused on issues including UN reform; LGBT and women's rights; the promotion of religious freedom and the protection of religious minorities; human trafficking; and democracy and human rights.

Before joining the U.S. government, Ambassador Power was the Anna Lindh Professor of the Practice of Global Leadership and Public Policy at Harvard University's John F. Kennedy School of Government, teaching courses on U.S. foreign policy, human rights, and UN reform. She was also the founding executive director of the Carr Center for Human Rights Policy.

Ambassador Power is the Pulitzer Prize-winning author of "A Problem from Hell": America and the Age of Genocide (2002) and Chasing the Flame: Sergio Vieira de Mello and the Fight to Save the World (2008), the basis for the award-winning HBO documentary, "Sergio." She is also the recent co-editor of The Unquiet American: Richard Holbrooke in the World (2011). Ambassador Power began her career as a journalist, reporting from places such as Bosnia, East Timor, Kosovo, Rwanda, Sudan, and Zimbabwe, and contributed regularly to The Atlantic Monthly, The New Republic, the New York Review of Books, and The New Yorker Magazine.

Ambassador Power immigrated to the United States from Ireland at the age of nine. She graduated from Lakeside High School in Atlanta, Georgia and received a B.A. from Yale University and a J.D. from Harvard Law School. She is married to Cass Sunstein, with whom she has two young children.

Ambassador Ron Prosor



Ambassador Ron Prosor is the Abba Eban Chair of International Diplomacy at the Interdisciplinary Center Herzliya. From 2011-2015, he was Israel's 16th Permanent Representative to the United Nations. In his more than two decades with the Ministry of Foreign Affairs, Mr. Prosor carved out an

international reputation as one of Israel's most distinguished diplomats. Between 2004 and 2007, Mr. Prosor served as Director General of the Ministry of Foreign Affairs, overseeing Israel's 2005 disengagement from Gaza.

Subsequently, he spent four years as Israel's Ambassador to the United Kingdom, where he earned plaudits for his articulate and forthright defence of Israel's position, publishing numerous articles in the British press and addressing a wide range of audiences. Mr. Prosor's previous overseas service has included roles in Washington, London and Bonn. He was instrumental in establishing diplomatic relations behind the Iron Curtain following the fall of the Berlin Wall in 1989.

A prolific writer and commentator, Mr. Prosor's op-eds have appeared in many high-quality newspapers and journals.

Dr. Shmuel Rosenman



Dr. Shmuel Rosenman, is World Chairman of the March of The Living, since 1988.

Holding a Ph.D in Administration from Pennsylvania State University. He is teaching at Bar Ilan University and Ashkelon College , Economic,Logistics and Health Organization.

He has also held positions as chairman of Israel Small and Medium Enterprises Authority, CEO of a major health fund, and director-general of secondary education for the Municipality of Tel Aviv.

In a recent on-line article, he wrote, "More than 220,000 participants have experienced March of the Living International (MOLI) trips to Eastern Europe and Israel and now MOLI has published a study examining the effects that the program has had on its participants." One effect: 54 percent of respondents said the March had made them more tolerant toward other groups.

The Honorable Chief Justice, Prof. Sam Rugege



Justice Sam Rugege is Chief Justice of the Republic of Rwanda. He was educated at Makerere University in Uganda, Yale Law School, and Oxford University. He was a lecturer in law at Makerere University before being forced to flee the terror of the Idi Amin regime in 1976. He then taught at the Universities of Lesotho

and Swaziland. Before being elevated to the bench, Chief Justice Rugege was a professor of law at the University of the Western Cape (UWC), in Cape Town, South Africa.

While at UWC, Justice Rugege was a consultant to the commission that drafted the post-genocide Rwanda Constitution of 2003 which ushered in a new era, providing respect for the rule of law, independence of the judiciary, democratic elections, power-sharing, and protection of fundamental rights and freedoms.

He was appointed to the Supreme Court of Rwanda in 2004 as Deputy Chief Justice and became Chief Justice in 2011. He has been closely involved in the transformation of the Rwandan judiciary into an independent, efficient, and accessible justice system. He has published academic articles and made presentations at conferences around the world.

The Honorable Ayelet Shaked



Minister Ayelet Shaked was appointed Minister of Justice for Israel in 2015. She has been serving as a member of the Knesset for the Jewish Home Party since 2013. While running in her party's primaries, she was elected second, as the "first woman" of the party, and the only secular woman ever elected in the list.

From 2006 to 2008, she was office director for Benjamin Netanyahu. In 2010 she established the "My Israel" movement with Naftali Bennett, and led it until 2012. Since her election, she has been an active member of various Knesset committees, including the Economic Affairs Committee, the House Committee, and the Committee on Foreign Workers. She is a member of lobbies to promote the employment of Arab women academics, for female Knesset Members, for equality in employment, for alliances with Christians, and for the hi-tech Industry, where she began her career. Minister Shaked also holds a degree in electrical engineering and computer science from Tel Aviv University.

Professor Elie Wiesel



Nobel Peace Laureate Elie Wiesel's personal experience of the Holocaust has led him to use his exceptional talents as an author, teacher, and storyteller to defend human rights, oppressed people and peace throughout the world.

After the Second World War, Mr. Wiesel became a journalist in Paris. Yet he remained silent about the horrors he had endured in the Nazi death camps. His breakthrough, both personally and internationally, came with the publication of "Night" ("La Nuit"), a shattering evocation of the Holocaust that has sold millions of copies and been translated into 30 languages.

Mr. Wiesel has since written more than 40 books, winning many awards, including the Prix Médicis for "A Beggar in Jerusalem" and the Prix Livre Inter for "The Testament." He has written two volumes of memoirs, "All Rivers Run to the Sea" and "The Sea Is Never Full," in addition to his accounts of the Holocaust.

Since 1976, Mr. Wiesel has been Andrew W. Mellon Professor in the Humanities at Boston University, where he also holds the title of University Professor.
